

## **Overdraft Service Disclosure**

#### What You Need to Know about Overdrafts and Overdraft Fees

An overdraft\_occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

- 1. We have standard overdraft practices (Courtesy Pay) that come with your account.
- 2. We also offer overdraft protection transfer plans, such as a link to a UFCU savings, money market or line-of-credit account, which may be less expensive than our standard overdraft practices. To learn more, ask us about these plans.

This notice explains our standard overdraft practices.

#### What are the standard overdraft practices that come with my account?

We **do** authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

**Beginning August 15, 2010**, we **do not** authorize and pay overdrafts for the following types of transactions unless you ask us to:

• Everyday debit card signature transactions

We pay overdrafts at our discretion, which means **we do not guarantee** that we will always authorize and pay any type of transaction. If we **do not** authorize and pay an overdraft, your transaction will be declined.

### What fees will I be charged if UFCU pays my overdraft?

Under our standard overdraft practices:

- We will charge you a fee of \$40 each time we pay an overdraft.
- There is **no limit** on the total fees we can charge you for overdrawing your account.
